### **DISCUSSION**

Hancock Park District Report: Jane McCleary from the Blanchard River Watershed Partnership asked if it would be possible to list the Hancock Park District as a partner on the city's Urban Prairie Project. After discussion, the topic was tabled until the next Board of Park Commissioners meeting on October 14. The Blanchard River Watershed Partnership and Toledo Zoo's Wild Toledo have scheduled an informational meeting for members of the community on Monday, September 15. The benefits of urban prairies will be presented.

The playground in the Oxbow Bend Activity Area is finished. The large hackberry tree near the McKinnis House was removed. The painting of the Oakwoods Nature Preserve Discovery Center has started.

Summer Camps were successful with over 300 participants. The Hike-It program has 161 participants to date. Fall public programs are open for registration. History Comes Alive for fourth graders will be held at Litzenberg Memorial Woods in a few weeks. A full week of school groups is being planned.
