DISCUSSION

Hancock Park District Report:

The tentative schedule for proposed improvements at Great Karg Well Historical Site includes bid advertisement in March, start of construction in April, and end of construction in June. The tentative schedule for proposed restroom replacements at Riverbend Recreation Area includes bid advertisement in March, start of construction in April (building kits are scheduled for delivery to the Riverbend Recreation Area Maintenance Facility for storage on April 3), and end of construction in June. The tentative schedule for proposed parking lot and walkway improvements at Litzenberg Memorial Woods includes bid advertisement in May, start of construction in June, and end of construction in September; meetings have been scheduled to review survey results and discuss concrete walkway, pad, and plaza locations.

Jon Wells has been hired as park manager central. He is scheduled to begin work on March 6. The new Kubota RTV at River Landings Maintenance Facility has worked well on the Blanchard River Greenway Trail and on paved walkways at Litzenberg Memorial Woods when snow plowing. It has improved customer service. The same vehicle has been ordered for use at Riverbend Recreation Area.

The puppet show was attended by 425 children; 17 shows were conducted. School days and public day for Maple Sugaring are scheduled for March. All volunteer positions for that event have been filled. New snowshoes have been purchased. Sizes now range from 21" to 25" to 27" and the inventory has increased from five pair of snowshoes to 17 pair of snowshoes. The permanent part-time program specialist position remains vacant, but a telephone interview has been scheduled with a person attending the University of Montana in Missoula. She worked for the Hancock Park District while participating in Findlay High School's mentoring program. Spring programs and summer camps are now being publicized and promoted.

The 2022 - 2023 Hunting with Permission Game Management Program went well. Thirty-five permits were issued. Twenty-one permit holders hunted (60%). There was a total of 94 visits, which is the highest participation in the last six years. Hunters took three bucks, two does, and 23 squirrels.
